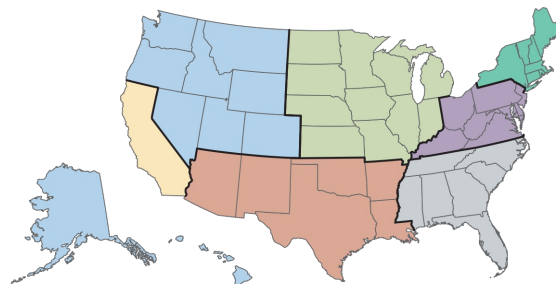


Clean Cities and Communities Contacts
